

# **Investment Objective & Strategy**

The Fund's investment objective is long-term capital appreciation. The Fund invests mainly in stocks of U.S. companies, emphasizing those companies with financial results which PRIMECAP Management Company believes will evolve materially better than consensus expectations. Through its research, the advisor identifies stocks that it believes over a three- to five-year time frame will outperform the S&P 500<sup>®</sup> Index. The advisor looks for companies that in its judgment will grow faster and/or will be more profitable than their current market valuations suggest, and for companies with asset values that are not adequately reflected in their stock prices.
